The Act governs how businesses collect, store, and manage personal information. Compliance with the POPI Act, or POPIA compliance, involves aligning organizational processes with the law's stringent requirements.



Who Needs to Comply?

The POPI Act applies to all processing of personal information which is entered into a record by a responsible party who is domiciled in South Africa, or who makes use of means in South Africa (except when those means are only used to forward information through South Africa).

Consequently, all businesses, regardless of their core activities, must comply with the POPI Act as they will always be processing information related to employees, suppliers, or clients.

POPI Act Requirements and the Importance of Backup + Recovery

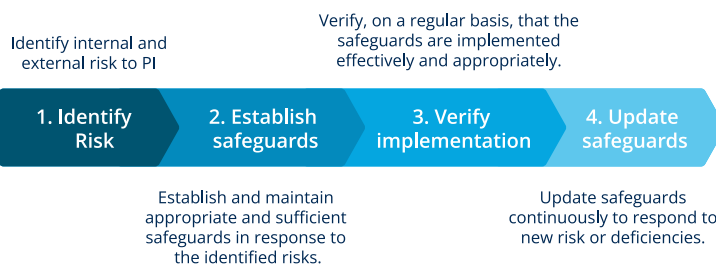
Organizations must secure the integrity and confidentiality of personal information (PI) in their possession or control by taking appropriate, reasonable technical and organizational measures to prevent the: data subject or the Information Regulator on their behalf.

- Loss of personal information
- Damage to personal information
- Unauthorized destruction of personal information
- Unlawful access to personal information
- Unlawful processing of personal information

The security measures must be proportionate to the nature and type of personal information being processed.

Consequences of Noncompliance

The POPI Act outlines both minor and severe offences, each with specific penalties and administrative fines.

Less Serious

Fine: Not exceeding R10 million

Imprisonment: Not exceeding 12 months

More Serious

Fine: Not exceeding R10 million

Imprisonment: Not exceeding 10 years

It's important to note that individuals responsible for ensuring compliance may face legal liability and potential imprisonment.

Additionally, the Act provides for civil actions for damages resulting from non-compliance, which can be initiated by the data subject or the Information Regulator on their behalf.
